


Checklist: "Secure Your Gym in 10 Points"






Opt for smart access card systems

Many gyms already use access card systems, and we understand the reasons for this choice due to the numerous benefits they offer. 5 Update your fire extinguishers

Fire extinguishers should be located within 25 meters, and their content should be suitable for the nature of your premises and the type of fire that may occur.

It is also essential not to overlook the annual inspection of your fire extinguishers. This check ensures that there is enough compressed air, and the content is still usable. If you don't know when your fire extinguishers were last checked, look for a small white sticker on the side of each unit indicating the date of the last maintenance.



Review fire alarm and evacuation system

In the event of a fire, it is essential that everyone in your premises knows the procedures to follow.

- Are all your premises equipped with smoke detectors?
- How is your fire alarm and evacuation system configured, and is it operational?

We recommend testing it regularly, every month and every quarter, to ensure it is functioning correctly.

Establish clear procedures for your staff

In a fire situation, it is essential that your team is well-informed about the procedures to follow. Does your staff have the necessary knowledge and training? This includes not only the ability to use extinguishing equipment such as fire extinguishers but also the skill to guide team members to safety in the event of a major fire. It is essential that your employees have the skills they need, and it is equally important to have a clear training plan that indicates which employees have undergone which training and the next employee to be trained.
